Eligibility:

Open to all Artists in Northern California.

Media Categories:

Watercolor, Oil, Acrylic, Pastel, Ink/Charcoal/Pencil, Mixed Media and 3D

Rules of Entry:

Each artist may submit up to three (3) works of which only two (2) maybe selected. All entries submitted for judging must be available for the exhibit. All work must be original, not taken from previously published materials and submitted by the artist. Works must be completed within the last two calendar years and not previously submitted to the Northern Mines Exhibit. Works produced in workshops and or under supervision are not eligible.

Pioneer Arts reserves the right to refuse, upon arrival, any piece that does not match the digital image and/or does not meet the framing criteria.

Entry Fee: - non refundable

To Enter:

Submit your completed and signed entry form, fee (checks are payable to Pioneer Arts, Inc.), a self addressed postage envelope for notification and a CD with digital image(s). If you want your CD returned please enclose another self addressed envelope with proper postage. CD will not be returned if envelope and postage does not meet postal requirements.

Digital Entries:

Make sure that the digital images of your artwork are of high quality, look professional and accurately represent your work. Paintings received which do not match the digital image may be rejected. Use at least a 3 Mega pixel digital camera. Must be high resolution. Image size should not exceed 2000 pixels on the longest size of the image. Minimum 300dpi. Save image as: A_title of work.jpg or tiff; B_title of work.jpg or tiff; C_title of work.jpg or tiff on PC platform.

Multiple images may be saved onto one CD. Write on CD in permanent ink entry titles and your name in the same order as on the entry form. Image(s) CD to be submitted by mail only with entry form and entry fee. Mail must be postmarked no later than October 12, 2010.

Accepted Works:

Work may be hand delivered or shipped. Shipping instructions will be included in your acceptance letter. There is a \$20.00 handling fee for shipped works. Shipped paintings must use Plexiglas in lieu of glass. All paintings must be dry, suitably framed and wired or gallery wrapped. Wire ends must be taped. No saw-tooth hangers. Work is not to exceed 45" in any direction (90 united inches), including frame. For 3-D size is not to exceed 24" per side and a weight limit of 50lb per each piece. Accepted artists will need to sign the waiver of responsibility form required by the Center for the Arts which will be sent to you along with your acceptance letter.

Commission:

30% commission on all sales resulting from the show payable to the Center for the Arts.
